About this Grant

Manningham Council is offering small grants up to \$1,000 for community groups or organisations to **come together** during 16 Days of Activism 25 November – 10 December 2024 **to spread the message to the Manningham community that violence against women, girls and non-binary people is always unacceptable**. This application form is for not for profit organisations or community groups applying for 16 Days Small Grant funding of up to \$1,000. The funded activities are to be held in the City of Manningham targeting the Manningham community.

Am I allowed to apply?

You can apply for this grant if you are a community group or organisation that is registered as a not-for-profit organisation or a company limited by guarantee. Community groups, organisations who are not registered as not-for-profit organisations may apply if they are auspiced by and eligible not for profit organisation.

What kinds of projects will be funded?

You could host an event like a morning tea, exhibition or panel discussion or develop a social media campaign or podcast, enews letter, or book club discussion on a related topic. As long as it is getting the message out to people that violence against women, girls and non-binary people is unacceptable in any context.

Manningham Council acknowledges that women and girls from multicultural communities, First Nations communities, the LGBTQIA+ community or people living with mental health issues or disability may be more at risk of experiencing family violence. Applications that intentionally include messaging to these groups or consider intersectionality, will be favourably considered, as will groups that traditionally attract men and boys.
